## I. Replacement of Section 6

Section 6—Imposition of Fee Increase.

Pursuant to section three-cc, article one, chapter seven (7-1-3c) of the West Virginia Code, the County Commission of Taylor County hereby imposes a fee of two dollars and fifty (\$2.50) per month per local exchange service line and line equivalent, except for Tel-Assistance lines, to finance maintenance costs of the Multi-County Enhanced Emergency Telephone System. Such fees shall become effective upon adoption of this Amendment by the Taylor County Commission.

## II. Replacement of Section 6 in E-911 Dispatch Service Contract Agreement

Section 6—Services and Fees to be Provided by Taylor County

Taylor County shall collect and forward as promptly feasible to the Harrison County 911, 735 Genesis Blvd, Bridgeport, WV 26330, payable to the Sheriff and Treasurer of Harrison County a monthly fee of \$2.50 per phone subscriber lines as specified in its adopted Enhanced 911 Ordinance. In addition, Taylor County will distribute on a quarterly basis to Harrison County the wireless fee paid by the Public Service Commission of West Virginia, All collections except those deducted by the phone company(s) for billing and nonpayment shall be for added without further withholding of funds. All funds forwarded to Harrison County in support of and for use to provide service to Taylor County shall be separately accounted for by the Harrison County Commission, which will use these funds exclusively to provide 911 service for Taylor County.
